



VOLUNTEERS WAIVER, RELEASE OF LIABILITY & COVENANT NOT TO SUE

BRIEF DESCRIPTION OF EVENT:

2007 NFL KICKOFF - INDIANAPOLIS - SHOW REHEARSALS AND PERFORMANCES AS SCHEDULED

- I attest and verify that I am free from all illnesses, injuries or defects and physically fit and sufficiently trained to participate in all activities associated with the program or event noted above. My participation in activities and events organized or sponsored by the NFL is voluntary.
- I am aware that there are risks to my personal safety or property, including the risk of serious injury and/or death in conjunction with my participation in activities and events, and I assume all risks associated with my participation in activities and events organized or sponsored by the NFL or connected with the NFL Kickoff, including death, injuries, or illness to person, and damage or loss to property.
- I do hereby, for myself, my heirs, administrators, executors, guardians, assigns, representatives, and next of kin, forever WAIVE, RELEASE, DISCHARGE, AND COVENANT NOT TO SUE the National Football League, its member professional football clubs, NFL Ventures, L. P. and each of their respective affiliates, officers, directors, agents and employees (collectively, with the "NFL Entities"), White Cherry Entertainment, The Indianapolis Colts Football Organization, the RCA Dome, the City of Indianapolis, IN, and/or their respective representatives, officers, directors, employees, agents, successors, and assigns (collectively, the "Releasees"). I further agree to indemnify, defend and hold harmless Releasees from any loss, liability, cost, claim or damages arising from my participation in or association with activities and events organized and sponsored by the NFL or connected with the NFL Kickoff Game in Indianapolis.
- I consent to administration of first aid and other medical treatment in the event of injury or illness and release and indemnify Releasees from any and all liability or claims arising out of such treatment.
- I hereby grant full permission to Releasees, as described above to use any photographs, images, videotapes, motion pictures, recordings, or any other record of the activities of the above named program or event for any legitimate purpose. All photographs, resumes, or other submissions taken by or given to the NFL shall be the property of the NFL.
- I understand that my belongings will be searched upon entry into the RCA Dome. By signing this document, I consent to such searches, and waive any related claims that I might have against the NFL Entities, its affiliates, or its agents. I understand that should I neglect to consent to these searches, I will be denied entry.

I hereby state that I have read and understand the above stated information. No promise, inducement, or agreement not expressed herein has been made to me. This form may be released to any third party in order that the applicant may receive medical care in the event of illness or injury.
